



## **Getting Up and Running**

Follow these three steps so you can start using Concur TripLink.



### **Launch Concur TripLink**

Check with the Concur Implementation team if Concur TripLink has been turned on and user permissions have been assigned.

DID YOU KNOW? You can also get support from your assigned Implementation Project Manager.



### **Apply Negotiated Rates**

Ask your suppliers for your company's unique discount codes. Add them to Concur, so they are applied to bookings.

TIP: Utilize the reporting functionality within Reporting tool or ask Client Support to see invisible spend for airlines, hotels, and car rentals as well as spend summaries "by traveler."



### **Add Your Policies**

Apply your policies and audit rules to bookings made with Concur TripLink network of suppliers by setting up your Travel Policy and Expense Audit Rules. ### **Tailor Your Solution to Meet the Needs of Your Business**

You can now select different messaging options for particular suppliers. Once a company has been chosen in the Manage TripLink Settings screen, you can choose a company travel configuration and three messaging options will be displayed to you for your employees.

#### **OPTION ONE**

### Supplier direct booking is allowed for all suppliers

Messaging is displayed to say employees are allowed to book directly with all travel suppliers and they will appear in Travel Partner Integrations and the SAP Concur App Center.



#### **OPTION TWO**

### Supplier direct booking allowed only for selected suppliers

Employees are informed that they are allowed to book directly only with the travel suppliers selected by the company, which will be marked as preferred.




#### **OPTION THREE**

# Supplier direct booking is discouraged

Messaging displayed will encourage employees to use the company's other preferred methods of booking, but they can still connect to travel suppliers in Travel Partner Integrations and the SAP Concur App Center.

### **Inactivating a Concur TripLink Supplier**

If necessary, you can request to inactivate a Concur TripLink supplier and remove it from the SAP Concur App Center and Travel Partner Integrations. This is strongly discouraged, as it may result in a loss of visibility into bookings made outside of your organization. Instead, we suggest that you select Option 2 and discourage supplier direct bookings for specific travel partners.
